Airports, trains, LSE stuck after outage

Airline operations face disruption after global computer outage.

Press Trust Of India

NEW DELHI /MUMBAI: airlines expe-Indian rienced technical and operational disruptions after a widespread global computer outage created chaos at airports as passenger check-ins were delayed with airlines resorting to issuing manual boarding passes.

Union Civil Aviation Rammohan Minister Naidu assured the passengers that his ministry and Airports Authority of India (AAI) are actively managing the situation using manual methods to ensure minimal disruption. IT Minister Ashwini Vaishnaw said his ministry was in touch with Microsoft and added that NIC network is not affected.

In a post on X, IT Minister Vaishnaw said the reason for this outage has been identified and updates have been released to resolve the issue. CERT is issuing a technical advisory, he wrote. "MEITY is in touch with Microsoft and its associates regarding the global outage... NIC net-

"NSE (National Stock Exchange) and NCL (NSE Clearing Ltd) are working normal today," NSE's spokesperson said in a statement. Separately, a BSE spokesperson said the bourse is "not impacted due to Microsoft issue. Our operations are running normal."

ED attaches Rs 300-cr worth land of M3M realty

NEW DELHI: The ED on Friday said it has attached land in Gurugram, worth over Rs 300 crore, of real estate group M3M as part of a money laundering probe linked to an alleged land fraud case that also involves Congress leader and former Haryana chief minister Bhupinder Singh Hooda.

A provisional order has been issued by the federal probe agency under the Prevention of Money Laundering Act (PMLA). The 88.29 acres of land is located in Basharia village of Harsaru tehsil in Haryana's Gurugram district that borders Delhi. The land is valued at Rs 300.11 crore, the Enforcement Directorate (ED) said in a statement.

SC seeks response from Centre

NEW DELHI: New Delhi: The Supreme Court on Friday sought responses from the Centre and others on a plea challenging a decision of the National Medical Commission (NMC) to not conduct NEET-Super Speciality examination in 2024.The National Eligibility-cum-Entrance Test-Super Speciality (NEET-SS) can be taken by doctors having postgraduate degrees like MD, MS, and DNB, or an equivalent qualification for admission to super-speciality courses.

A bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra was told by a lawyer, appearing for 13 aspirants, that the NMC has decided to not hold the exam this year. As per news reports, NEET-SS is likely to be conducted in January 2025.

UPSC files FIR against Puja Khedkar for forgery

NEW DELHI: The Union Public Service Commission (UPSC) on Friday took a series of action, including registration of a police case, against probationary IAS officer Puja Khedkar for fraudulently availing attempts in the civil services examination by faking her identity.

The commission has also issued a show cause notice for cancellation of her candidature of the civil services examination-2022 and debarment from future examinations and selections.

Khedkar, a 2023 batch probationary Indian Administrative Service

(IAS) officer, is accused of misusing power and privileges, by demanding perks and facilities she was not entitled for, during her training in Pune District Collectorate in Maharashtra recently.

She is accused of bullying everyone around and of placing a redblue beacon (indicating high-ranking official) atop a private Audi (a luxury sedan) car used by her that also had 'Maharashtra government' written on it during her stint.

After the Pune district collector flagged the matter, Khedkar was transferred to Washim District Collectorate in the Vidarbha region.

She was declared qualified in the civil services examination 2022. Based on the results declared last year by the UPSC, Khedkar was allocated the IAS and her home state Maharashtra as a cadre.

RAIPUR: A widespread global computer outage on Friday led to several Indian airlines facing technical and operational disruptions, which also impacted Swami Vivekananda Airport in Chhattisgarh's Raipur, where nine flights belonging to IndiGo Airlines were cancelled, officials said. These comprise departures and four arrivals, they said, adding a few flights were also delayed. Officials, how-

ever, did not give details of these delayed flights. "Five flights from Raipur to Bengaluru (at 19:55 hrs), Kolkata (20:45 hrs), Hyderabad (20:55 hrs), Mumbai (21:05 hrs) and Delhi (21:20 hrs) and four arrival flights, all belonging to IndiGo, have been cancelled following the IT outage," an airport official here told PTI. Several passengers said the airport authority and airlines were not giving them proper updates. Talking to reporters, Suruchi Shrivastav from

Sand mafias are capitalizing on rainy season situation, selling the sand at exorbitant rates

RAIPUR: In Chhattisgarh's Raipur district, the price of sand has skyrocketed from Rs 1,500 to Rs 18,000, thanks to illegal storage practices. Sand worth approximately Rs 40 crore has been unlawfully stored along the banks of the Mahanadi River, with the Mines department failing to intervene. As the rainy season progresses, sand mafias are capitalizing on the situation, selling the sand at exorbitant rates. Last week, substantial quantities of sand were confiscated in Dhamtari and Mahasamund. Although permission has

been granted for sand storage at only 17 sites in Raipur, it is being stored at over 200 locations. According to the rules of the mineral department,

unauthorized storage should be confiscated, and the sand auctioned at government rates for public or government construction use.

Currently, one truck of sand, priced at Rs 9,000 to Rs 10,000, reaches construction sites at a cost of Rs 18,000 to Rs 20,000. The

government-fixed loading price is Rs 150 per cubic meter, translating to Rs 1,500 per truck. However, sand mafias are charging significantly higher rates. Additionally, those storing sand illegally are demanding royalties, with Rs 4,000 being charged for a roy-

Congress plans historic Assembly gherao on July 24: Baij expects massive turnout

RAIPUR: Congress leaders and workers gathered at Congress Bhawan to strategize for a major protest set to gherao the state assembly on July 24. State Congress President Deepak Baij has set an ambitious target of mobilizing more than 20,000 people for the demonstration.

He argued that altering the scheme's name has sparked widespread anger, not only among the specific community but across the state. He accused the BJP government of sowing societal divisions with such actions.

NEW DELHI: The Bharat Rashtra Samithi has topped the income chart among regional parties for the financial year 2022-23 with Rs 737.67 crore, 42.38 per cent of the total, according to poll rights body ADR.

The top five parties with the highest expenditure are All India Trinamool Congress which spent Rs 181.18 crore or 37.66 per cent, followed by YSR-Congress which spent Rs 79.32 crore or 16.49 per cent, BRS, which spent Rs 57.47 crore or 11.94 per cent, DMK, which spent Rs 52.62 crore or 10.94 per

cent, and the Samajwadi Party, which spent Rs 31.41 crore or 6.53 per cent of the total expenditure, ADR said.

In a revealing analysis of the financial health of India's regional political parties, the Association for Democratic Reforms (ADR) has disclosed detailed income and expenditure reports for 39 out of 57 regional parties for the fiscal year 2022-23.

After BRS, the TMS had the highest income of Rs 333.45 crore or 19.16 per cent, while the Dravida Munnetra Kazhagam (DMK) reported an income of Rs 214.35 crore or 12.32 per cent of the

- the LTTE leaders, operatives and supporters have been inimically opposed to India's policy on their organisation and action of the State machinery in curbing their activities;
- cases have been registered under the Unlawful Activities (Prevention) Act 1967, against LTTE, pro-LTTE groups or elements since the last notification published vide number S.O. 1730 (E), dated the 14th May, 2019 which indicate that LTTE and its remnant cadres, followers and supporters are involved in various criminal activities, including smuggling of illegal drugs, arms for furtherance of objective of the LTTE;

AND WHEREAS the Central Government is of the opinion that the aforesaid activities of the LTTE continue to pose a threat to, and are detrimental to the sovereignty and territorial integrity of India as also to the public order and, therefore, it should be declared as an unlawful association;

AND WHEREAS the Central Government is further of the opinion that since LTTE continues —

- with its disruptive, separatist and secessionist activities, which are prejudicial to the integrity and sovereignty of India; and
- its strong anti-India posture thereby posing a grave threat to the security of Indian nationals,

t is necessary to declare LTTE as an unlawful association with immediate effect;

NOW, THEREFORE, in exercise of the powers conferred by sub-sections (1) and (3) of section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), the Central Government hereby declares the Liberation Tigers of Tamil Eelam (the LTTE) as an unlawful association and directs that this notification shall, subject to any order that may be made under section 4 of the said Act, have effect for a period of five years from the date of its publication in the Official Gazette.

Pendency of cheque bounce a serious concern

NEW DELHI: Expressing "serious concern" over pendency of a large number of cheque bounce cases, Supreme Court has said courts should encourage compounding of offences under the Negotiable Instruments Act if parties are willing to reach a compromise.

A bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah set aside the conviction of a man named P Kumarasamy in a cheque bounce case, after noting that the parties have entered into a settlement agreement and Rs 5.25 lakh has been paid to the complainant. "A large number of cases involving dishonour of cheques are pending before courts which is a serious concern for our judicial system. Keeping in mind that the 'compensatory aspect' of remedy shall have priority over the 'punitive aspect', courts should encourage compounding of offences under the NI Act if parties are willing to do so," the bench said in its July

11 order.

Balancing local preferences with economic realities

n a move that has ignited widespread debate, the Karnataka Government has temporarily shelved Lits proposed reservation Bill for Kannadigas in private firms following intense backlash from business and industry leaders. The Karnataka State Employment of Local Candidates in the Industries, Factories and Other Establishments Bill, 2024, which aimed to mandate significant local hiring quotas, has faced criticism for its potential economic repercussions. The Bill, initially approved by the state cabinet, sought to ensure that 50 percent of management roles and 70 percent of non-management roles in private establishments were filled by local candidates. This proposal, while well-intentioned in promoting local employment, has been met with considerable opposition. Prominent organizations, including NASSCOM, have warned that such restrictions could drive businesses to relocate, exacerbating the scarcity of skilled local talent. Karnataka, renowned as India's technological hub and a beacon of economic progress, risks undermining its business-friendly reputation with such regressive legislation. The state's attempt to follow in the footsteps of Haryana, which faced judicial rejection of a similar law, highlights a recurring issue across various states. Andhra Pradesh and Jharkhand have also experienced setbacks with comparable mandates, illustrating the broader challenge of balancing local employment goals with the realities of a globalized economy. While the notion of promoting local employment has gained traction, especially under the 'vocal for local' campaign, the potential adverse effects on merit and skill-based hiring cannot be ignored. In the fiercely competitive landscape of state-level economic development, policies perceived as protectionist may deter investment and innovation. The swift response from Andhra Pradesh, inviting businesses to relocate to Vizag, underscores the high stakes involved. For Karnataka, a prudent approach would be to reconsider the Bill and engage in more comprehensive discussions with all stakeholders. Ensuring that local aspirations are met without compromising the state's economic dynamism is crucial.

Production-Linked Incentive (PLI) Scheme: India Wants More

aunched by the Government of India in 2020, the Production-Linked Incentive (PLI) scheme aims to enhance the country's manufacturing capabilities and boost exports by offering financial incentives to companies based on incremental sales of goods manufactured in India. Integral to India's Atmanirbhar Bharat mission, the scheme focuses on reducing import dependence and strengthening domestic production capabilities. With an incentive outlay of Rs 1.97 lakh crore, the scheme covers 14 key sectors, including electronics, pharmaceuticals, food processing, and telecom products.

By November 2023, the PLI scheme had attracted investments exceeding Rs 1.03 lakh crore, resulting in production and sales worth Rs 8.61 lakh crore and generating employment for over 6.78 lakh individuals. Exports under the PLI scheme reached Rs 3.2 lakh crore, significantly impacting India's trade balance. Notable growth was observed in sectors such as electronics, pharmaceuticals, telecom, and food processing. For example, local manufacturing of smartphones increased by 5%, and imports of plastic parts and camera lenses declined by 33% in FY24. Pharmaceuticals saw exports rise by 9.67% YoY to USD 27.9 billion in FY24, along with a 4.54% reduction in imports of bulk drugs. The telecom sector achieved a 60% import substitution, with a 370% increase in sales of telecom products by PLI beneficiaries. The food processing sector boosted organic product exports, creating 2.37 lakh iobs by September 2023.

Despite its the PLI scheme faces several challenges. Operational glitches, such as land acquisition issues and procedural delays, have hindered smooth implementation. Ensuring companies meet production and investment targets while maintaining transparency and accountability remains a challenge. Infrastructure development in some regions is slow, and integrating into global supply chains poses hurdles due to quality-related rejec-

global supply chains. * Incentives for setting up industrial units in eastern states to promote balanced regional industrialization, preventing concentration of industrial growth in certain

* Linking eligibility criteria for PLI benefits to skilling initiatives and hiring targets, ensuring inclusive job creation and improving employment

Improving operational processes for foreign investors by streamlining procedures for land acquisition, utility connections, and clarifying qualification criteria, attracting more foreign direct invest-

* Enhanced focus on R&D and sustainable practices, with increased incentives and support for research and development, particularly in sectors like battery manufacturing and recycling, supporting startups and innovations in sustainable mobility and recycling.

Robust monitoring mechcontinuous anisms and enhancements in infrastructure and workforce skills are crucial for the scheme's sustained success. Addressing these demands will help achieve broader national goals of enhancing India's manufacturing capabilities, reducing import dependency, and elevating India's position in the global manufacturing sector. Revolutionizing cobra bite treatment with old drug

Snakebites cause significant harm worldwide. Research reveals century-old blood-thinners may revolutionize treatment, especially for cobra venom injuries. by Tian Du and Greg Neely

approximately 1.8 million people worldwide are bitten by snakes, resulting in up to 138,000 deaths and 400,000 cases of permanent scarring and disability. Many cobras possess tissue-damaging venoms that current antivenoms cannot effectively treat. However, recent research suggests that inexpensive, widely available blood-thinning medications could be repurposed as antidotes for these venoms.

Utilizing CRISPR gene-editing technology, researchers have gained new insights into how these venoms attack cells. They discovered that a class of drugs called heparinoids can protect tissue from venom damage. This groundbreaking research, published in Science Translational Medicine, has the potential to revolutionize the treatment of cobra bites.

Snake venoms consist of various compounds that generally target the heart, nervous system, or local tissue at the site of exposure. While most research focuses on the deadliest venoms, less lethal but still harmful venoms, such as those from cobras, have received less attention. In regions where cobras are prevalent, serious snakebites can lead to life-altering injuries, including amputations, which can devastate individuals' livelihoods. The World Health Organization has rec-

ognized snakebite as a "Cat-

egory A" neglected tropical disease and aims to halve the burden of snakebites by

2030. Currently, the treatment for snakebites is antivenoms. These are produced by exposing non -human animals to small amounts of venom and harvesting the antibodies produce. Although antivenoms can save lives, they have significant limitations. Each antivenom is specific to one or more snake species, making them prohibitively expensive and often unavailable. They require cold storage and must be administered via injection in a hospital. Additionally, antivenoms cannot prevent local tissue damage because the antibodies are too large to reach peripheral tissues, such as limbs.

A research team from the University of Sydney, the Liverpool School of Tropical Medicine, and Instituto Clodomiro Picado in Costa Rica sought alternative treatments for snakebites. They began by studying cobra venoms, specifically those from the African spitting cobra, known for causing tissue damage. Using a whole genome CRISPR screen, they disabled different genes in human cells and exposed these cells to the venom to identify which genes were necessary for the venom to inflict damage. The researchers discovered that certain enzymes required by cobra

venoms to kill human cells are responsible for producing long sugar molecules called heparan and heparin sulfate. These molecules, found on the surface of human and animal cells, play a crucial role in the immune response. Snake venoms have evolved to exploit these molecules,

causing tissue damage. Heparin, a blood-thinning medication used for nearly 100 years, was tested on human cells to see if it could act as a decoy target for the venom. Remarkably, the venom no longer caused cell death when heparin was added, even after the venom had been introduced. This protective effect was also observed with venoms distantly related

Asian cobras. Further testing showed that injecting a smaller synthetic version of heparin, called tinzaparin, reduced tissue damage in mice with an artificial "snake-

The research team identified that heparin inhibits "cytotoxic three-finger toxins," which are a major cause of tissue injury. Until now, no drugs were known to counteract these toxins. The next step is to test heparin's effects in humans. The ultimate goal is to develop a snakebite treatment device containing heparinoid drugs. similar to the EpiPen adrenaline injectors used for severe allergic reactions. These devices could be distributed to individuals at high risk of cobra bites. Heparinoids are already approved by the US Food and Drug Administration for self-administration and are stable at room temperature, making them more accessible in remote regions.

Other studies have confirmed the potential of repurposing drugs for snakebite treatment, signaling a new era where treatments do not solely rely on costly antivenoms. The researchers' technique, which has previously been used to investigate other venoms such as those from box jellyfish, is uncovering valuable information that could lead to the development of universal and broad-acting venom antidotes.



NEW DELHI: Indian Hotels Company Ltd on Friday reported a 10.25 per cent growth in consolidated net profit to Rs 260.19 crore in the June 2024 quarter, on higher revenue from operations. Indian Hotels Company Limited (IHCL), the country's largest hospitality company, which owns the 'Taj' brand of luxury hotels, had a profit of Rs 236.01 crore in the year-ago period, according to a regulatory filing. Its total income during the April-June quarter under review rose to Rs 1,596.27 crore, from Rs 1,515.70 crore in the corresponding period of the last financial year. However, the company's total expenses also increased to Rs 1,267.78 crore against Rs 1,221.76 crore a year ago, the filing showed. In a separate filing, IHCL informed regarding the transfer of the restaurant business of its wholly owned overseas subsidiary -- Taj International Hotels Ltd -- to St James Court Hotels Ltd, another subsidiary of the company.







'Panghal's resilience key to Olympic success'

Former Commonwealth Games champion Akhil Kumar believes boxer Amit Panghal's resilience, after setbacks, makes him one of India's strongest athletes for the Paris Olympics.

NEW DELHI: Former Commonwealth Games champion boxer Akhil Kumar believes a battle-hardened Amit Panghal, who persevered through the setback of being dropped from the national team before roaring back to qualify for the Olympics, will be among the most mentally strong Indian athletes competing in the Paris Games.

After the first-round exit from Tokyo Olympics, Panghal lost his spot in the team on the basis of Boxing Federation of India's evaluation system, which was drafted by then High Performance Director Bernard Dunne.

"Amit is in a strong place now because he has made a comeback and seen the tough times in the past few years," Akhil told PTI on the sidelines of a panel discussion on India's Olympic prospects hosted by the Delhi Sports Journalists Association in collaboration with the Sports Authority of India.

The snubs severely dented Panghal's confidence and made him question his abilities.

India triumphs over Pak in Asia Cup T20 opener

India kicked off their Women's T20 Asia Cup campaign with a dominant seven-wicket victory over Pakistan, thanks to Deepti Sharma's stellar bowling and a strong opening partnership.

India secured a decisive seven-wicket victory over Pakistan in their Women's T20 Asia Cup opener.

DAMBULLA: Title contenders India saw off Pakistan by seven wickets in their Women's T20 Asia Cup opener here on Friday. Opting to bat first, Pakistan were bowled out for 108 with experienced spinner Deepti Sharma (3/20) emerging as the most successful bowler. Renuka Singh (2/14) and Pooja Vastrakar (2/31) also chipped in with wickets at crucial juncture to keep Pakistan on a tight leash through their innings.

In reply, India completed the chase in 14.1 overs with the opening duo of Smriti Mandhana (45) and Shafali Verma (40) putting on 85 runs in 9.1 overs.

India, after being asked to bowl first, tasted their first success in the second over itself when pacer Pooja Vastrakar dismissed Gull Feroza, caught by skipper Harmanpreet Kaur at

Russia seeks 18-year sentence for US reporter on trial for spying

YEKATERINBURG: Russian prosecutors sought a prison sentence of 18 years on Friday for Wall Street Journal reporter Evan Gershkovich, who is on trial on espionage charges that his employer and the US have denounced as fabricated. Gershkovich, 32, was arrested March 29, 2023, while on a reporting trip to the Ural Mountains city of Yekaterinburg. Authorities claimed, without offering any evidence, that he was gathering secret information for the US. He pleaded not guilty, according to the court, and The Wall Street Journal and the US government have called the trial a sham. Gershkovich appeared in court for a second straight day Friday as the closed-door proceedings in Russia's highly politicized legal system picked up speed. A verdict is expected later in the day, according to court officials.

UK airports, trains, Stock Exchange, NHS impacted by global IT outage



LONDON: The UK's airports and trains experienced delays, with the London Stock Exchange and the National Health Service among the other organisations in the country dealing with the fallout of a global IT outage on Friday that has grounded planes and caused chaos around the world. The outage, believed to be related to an issue at US-headquartered prolific cybersecurity firm Crowdstrike and Microsoft, seems to be affecting Windows PCs globally and has also forced 'Sky News' off the air.

MALE: Maldives has said that almost 68 per cent of the Hanimadhoo International Airport, being built under Indian assistance, is now complete, a project that India said will have a transformative impact on the entire northern region of the archipelagic nation. The Ministry of Infrastructure announced that 67.5 per cent of the construction on Hanimaadhoo International Airport - funded with an MVR 800 million Line of Credit by the Indian government - is complete and the project is progressing steadily. "Awarded to India's GMC in September, the airport expansion includes a 2.7-kilometre runway, a 1.3 million-passenger terminal, and a jet fuel storage facility. According to the Infrastructure Ministry, 97 per cent of the 2,400-meter runway and apron is now finished, with the completed section already in use. The entire project is expected to be completed by November," news portal TruthMV. com said on Thursday. Hanimaadhoo is about 290 km north of Male, the capital of the archipelago. "Hanimadhoo International Airport, being built under Indian LoC assistance, will have a transformative impact on northern region of Maldives.
